

Annual Ticket Terms & Conditions 2021

Scudamore's Punting Company Ltd

1.	Users	Valid users of Annual Tickets ("Ticketholders") are as follows:- <i>Newton</i> : purchaser (or the recipient if given as a gift). <i>Pepys</i> : purchaser (or recipient) plus one other nominated user. <i>Corporate</i> : employees or members of the nominated organisation.
2.	Non- transferability	Tickets are non-transferable to users other than the Ticketholders. Once confirmed, the identity of the Ticketholders cannot be changed.
3.	Validity	Tickets are valid from the date of purchase for one calendar year ("Term"), after which date they expire, unless the term has been extended in writing by Scudamore's.
4.	Applicable days	Tickets are valid seven days per week, with the exception of 25 th December ("Applicable Days"). Please note: if we consider conditions to be unsuitable or unsafe on any given day, we reserve the right not to let out self-hire craft.
5.	Applicable hours	Tickets can be used from 09:00 on Applicable Days. Craft must be returned 30 minutes before day's closing time as displayed at the punt station (the "Applicable Hours"). Any hire outside of the Applicable Hours will be charged at standard rates.
6.	Hire route	All Tickets apply to the Top River (Grantchester) only.
7.	Applicable station	Tickets may be used from our Mill Lane boatyard (Top River) only. The College Backs stations (Magdalene Bridge and Mill Lane) are excluded.
8.	Hire craft	Tickets are valid for the standard 6-person self-hire punts ("Hire Craft") only. Tickets are not valid for 12-passenger self-hire ferry punts on the Top River or for chauffeured tours.
9.	Sessions	Tickets entitle Ticketholders to one free self-hire session ("Hire Session") per Applicable Day. A Hire Session applies to only one craft and may be as short as one hour or as long as a day (i.e. the full Applicable Hours). Tickets cannot be used for more than one Hire Session per day - e.g. for Pepys Annual Tickets, both Ticketholders cannot use the ticket for separate Hire Sessions on the same day.
10.	Hire procedure	Hire Craft must be pre-booked and are subject to availability. Before hire commences pre-booked Ticketholders will be required to show valid photo ID and leave an electronic hire deposit via card Tokenisation. Please note that we are unable to authorise free Hire Sessions unless these requirements are met. Standard self-hire Terms & Conditions <u>apply</u>
11.	Prohibition on absentee hire	Ticketholders must be present on Hire Craft throughout Hire Sessions. The hiring of craft to "loan out" to third parties (i.e. the Ticketholder is absent for much or all of the session) is specifically prohibited. Flouting of this condition will lead to the immediate cancellation of the Ticket without refund of any monies paid for the said ticket.
12.	Prohibition on public and / or commercial use	Ticketholders are only entitled to use Scudamore's Hire Craft for private and personal purposes. Public and / or commercial use is specifically prohibited. Flouting of this condition will lead to the immediate cancellation of the Ticket without refund of any monies paid for the said ticket.
13.	Amendments	Scudamore's reserve the right to alter, amend or change these Terms & Conditions without prior notice. Any material changes will be communicated to Ticketholders in writing via email.
